• SMGC has extensive experience working in Nickel. SMGC is presently working with two nickel clients ranging from exploration through to supply to potential and existing process facilities. Since the ban has been in place previously exporting mines are now changing their focus to building process plants or to supplying ore to a process plant. For some this is a challenge as previous QA/QC data collected was collated for the purpose of ore extraction and export, but not for the level of detail required to produce a JORC Code 2012 Resource and Reserves Statement, and therefore to the level of detail required to support the data needed for supply a process plant or smelter.

#### Uniform Conditioning for JORC Resource Modelling

Uniform Conditioning is a process that has the potential benefit of increasing recoverable ore grade tonnages by increased visualisation and interpretation on a block by block basis. This has additional benefits when ore grade is set to a confined range. Block size review is reduced to a selected minable unit (SMU) allowing for a greater degree of accuracy and therefore not allowing higher grade ore to be lost in standard block averaging.

#### **Process - Uniform Conditioning and JORC Resources**

- Generate a geological model
- Additional interpretation of the geological model using Uniform Conditioning
- Re-calculate the geological Resource
- Prepare a JORC Resource Statement


